- 4 indoor sports include Poker, Rummy, 28 and 56 Card games


Except for Men's Cricket Tournament, all the other games were 100% free to our community members. For Mens Cricket too we charged a nominal fee of \$99/team (which was 51% less than the previous year).

#### STEP CHALLENGE

For the first time, KAW organized a 3-month STEP CHALLENGE (from May 1st to July 31st) so that our members in our community can get moving and stay fit and healthy.

Over 100 participants participated in the challenge, About 9 participants consistently achieved 20 - 25 K steps per day (620 - 775 K steps a month) and 20 members achieved 300 K steps. 


#### FATHER'S DAY HIKING

# KAW CHARITY & EDUCATION

#### MALAYALAM SCHOOL – AKSHARA KALARI

KAW is very proud of its Malayalam School (Akshara Kalari). KAW Malayalam School is the largest Malayalam School in the US under the Kerala Govt's Malayalam Mission Program with over 200 students and over 50 Volunteers this academic year.

This school runs independently and the academic year is from Sept – June. The school operates under the Malayalam school board led by the Principal – Smt. Latha Santhosh, Vice Principal – Smt. Vineetha Parammel, Community Members – Smt. Reshma Rajesh, Smt. Jayashree Narayanan, and 2022 EC Members – Smt. Remya Nair, Sri. Rahul Nair. Remya and Rahul were added to the board when the 2022 EC took office in March.

2022 EC had the privilege to graduate the first batch of students in this new structure and conducted the first Padonolsavam 2022 on June 5th, 2022. Over 100 students from all the classes participated and presented their learning skills through stories, poems, and drama. The event was very well received and the school received overwhelmingly warm feedback from all who attended especially the visiting parents from India. The student certificates and bookmarks made by Youth Club members, teachers, and volunteer appreciation gifts were also distributed during the event.

In August, the previous board members were renominated as per the nomination process mentioned in the KAW bylaws ARTICLE XI, SECTION VI.

Registrations for the 2022-23 academic year began in July. There were more than 200 student registrations and we accepted every registration. A total of 50 teachers also signed up for this academic year.



Praveshanolsavam 2022-23 was conducted online on Sept 21st, 2022 with a detailed presentation on the syllabus, expectations from students, guidelines, and Q&A sessions. Textbooks from Malayalam Mission were shipped from India and distributed to all students and teachers. The classes started in September.

#### BACK 2 SCHOOL KERALA

In the month of May 2022, right before the schools started in Kerala, KAW Youth Club came up with the idea to raise funds and support the underprivileged kids of Kerala to have an equal opportunity to start or to be back in school.

With our Youth Club's effort and the support of our community, we were able to support 300 kids with School backpacks and school supplies such as umbrellas, lunch boxes, water bottles, books, etc, and distributed them in 6 districts in Kerala.

Our Youth Club Volunteers and Kids from KAW Malayalam School wrote letters that were placed in every backpack.

Santhosh Nair, President of KAW was in Kerala and traveled to all 6 districts to distribute the Backpack kits

We were working on this project on a very aggressive timeline – 7 days precisely. In this short time, we identified deserving kids across 6 districts, raised funds, procured supplies, and transferred funds.



We partnered with Snehakoodu Abhayamandiram in Kottayam and Care & Share to execute this project.

#### KOZHUTHA KALAKUTTY – DRAMA

Our fundraising drama production, Kozhutha Kalakutty was a Mega Hit Show. The event was held on Oct 22nd at Shoreline Community College Theatre. The drama was directed by Dr. Thampi Sam Raj with over 50 casts and crew in different departments – Artists, Dance artists, choreographers, make-up artists, media, audio, effects, sound, lights, props, stage management, photography, videography, Emcees, Youth Volunteers.

We raised more than \$50K from the fundraiser. All proceeds of this event went to support palliative care projects in the US and Kerala. These funds were distributed to Pallium India, Solace, and LadyBug House during the KAW Christmas & New Year event



#### MICROSOFT POKER TOURNAMENT

On behalf of KAW, our friends at Microsoft under the leadership of Jyothish Nair along with Biju Mathew from EC organized the Microsoft Poker Tournament.

We raised more than 10K from the event. Prizes worth \$1500 were distributed

The funds will be distributed to the beneficiary Snehakoodu Abhayamandiram towards their building cost. Snehakoodu Abhayamandiram in Kottayam provides shelter to old age mothers and fathers who need compassion, love, and support



#### AWARDS & RECOGNITIONS

KAW Charity received 2 recognitions this year for the impact that KAW Charity is making in our community and Kerala over the past many years. We would like to congratulate our past Executive Committees and Community members for this recognition.

KAW won the best philanthropic (charity) association among the member associations of FOMAA. We won this award for charity efforts during the years 2020-2022.

KAW Charity was recognized by Care & Share for its extraordinary service to support various causes in Kerala for the past many years.



## TECHNOLOGY

#### TECHNOLOGY UPDATES

As part of website improvements, we streamlined the registration and pre-order forms used for various sports and cultural events.

Food pre-order forms were utilized this year for Onam, Picnic, and Xmas / New Year events without any issues. All outdoor sports events were registered online.

Zoho platforms were used to manage the Thattukada orders for the KAW Summer Picnic

For Kozhuthakalakutty - Drama event, we utilized the fundraising platform to enable ticketing and sales seamlessly. Check-in using a QR code was facilitated using the platform.

The backend database for the website was downscaled by the month of December to bring down the Microsoft Azure cloud bill.

#### WASHINGTON MALAYALEE CONNECTION

We have rebranded the whatsapp group "The KAW Community Group" to "Washington Malayalee Connection".

With Washington Malayalee Connection, our goal is to provide an open platform that connects individuals with the community - The community is growing, and there are many new members/ malayalees who are moving to Seattle. As KAW, it is important for us to create a sense of community, be accessible to all, improve community engagement, and create awareness that can make us stronger individually and together. Until this change, there was a perception that our channels are for broadcasting KAW updates only. We hope that with Washington Malayalee Connection, we can provide an open accessible gateway to our community and break the perception.



After this announcement, we had an increase in the number of participants from 300 to more than 490 participants

## **ELECTION & 2023-24 EC**
